

Capitec and Payfast: Festive Consumer Competition Rules

Prizes

30 x R2,000 cashback prizes into the winners' Capitec Live Better savings account

Competition period

- The competition will run from 7 November 2023 – 31 December 2023 (11:59pm).
- 15 winners will be announced on 5 December 2023 and on 5 January 2024 (before 5pm).

How to enter

For automatic entry into the competition:

- Pay the smart way with Capitec Pay on any website that uses Payfast
- One qualifying payment will count as one entry

Competition terms and conditions

By entering the competition, you agree to the following terms and conditions:

1. The name of the campaign is "Festive Consumer Competition" and Capitec and Payfast are the promoters.
2. The competition will run from 7 November to 31 December 2023 (11:59pm).
3. The competition is open to natural persons:
 - 3.1 Who are citizens and/or permanent residents of, and living in, the Republic of South Africa ("RSA")
 - 3.2 Who are in possession of a valid RSA identity document, or a valid passport endorsed with "permanent resident" status
 - 3.3 Who are 18 (eighteen) years of age or older
 - 3.4 Who are not employees whether permanent or contracted to work for Capitec Bank, Payfast or our Competition Partners
 - 3.5 Family members of those directly involved in the competition execution or fulfilment, production, management or marketing of the competition are also not eligible to participate in or enter the competition
4. Capitec and Payfast, its affiliates, employees, advertising agencies and suppliers will not be liable for the failure of any technical element relating to the competition that may result in any entry not being successfully submitted
5. The winners will be randomly selected by a computer-programmed algorithm
6. All valid entries collated will be entered into an automated random draw selection process weekly
7. Winners will be contacted by Capitec's Internal Marketing Team
8. Prizes: Each Capitec client that is successfully entered into the competition and passes the Selection process stands a chance to win only one of thirty R2,000 cash prizes.
